7. I will have no more than 6 dogs in my kennel. _____

8. I will allow the Animal Control Authority access to my property to inspect the kennel conditions.

I hereby certify that:

- Housing and kennel facilities are in good repair and structurally sound.
- Dogs outside will have access to shelter to protect them from weather elements.
- Any use of chains will be at least three times the length of the dog (nose to tail base), will be attached to a well fitted collar, and cannot become entangled with the chains of other dogs.
- Any enclosure will allow for the dog to fully turn, stand, sit and lie in a comfortable position.
- Temperature of indoor facilities will not be kept under 50 degrees Fahrenheit.
- Disposal facilities will be provided to minimize vermin, infestation, odors and disease.
- Adequate storage and refrigeration will be provided to protect food against contamination.
- The establishment shall be open for inspection by duly authorized city authorities at any reasonable time.
